### WHAT IS INCLUDED AND EXCLUDED FROM MY RIGHTS24 PLAN?

We cover civil, criminal and labour matters, but we do not cover pre-existing matters. That means a legal matter that was already in process at the time of taking the policy. However, even though we do not cover pre-existing matter, we will still provide you with limited legal advice over the phone. It simply means we will not be able to represent your matter in court. Violent crimes and contested divorces are also excluded. For a full list of inclusions and exclusions, please consult your policy documentation.

### WILL YOU REPRESENT ME IN COURT, IF NECESSARY?

Yes, we have a nationwide panel of attorneys that can represent you in your area, if necessary. Under your RIGHTS24 plan, provision is made for court representation where required for a matter that arises after the 3 month waiting period. Before that we will give you expert advice and guidance on the phone.
